This session will explore the diagnosis and management process of HLH, and will include a Q&A segment for additional information.

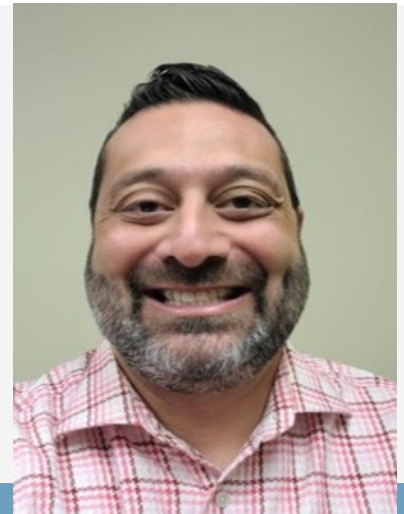
